Notably, Christ's Hospital still uses the same traditional uniforms that were introduced in 2014, with a staggering 95% of students voting to retain the classic look. In contrast, prestigious schools like Eton had more extravagant requirements until their dress codes were relaxed in 1972. School uniforms in the United States followed the British tradition but were initially limited to private and parochial institutions. An exception was found in government-run boarding schools for Native American children, which imposed military-style uniforms on students as early as the late 1800s. The first public schools in Maryland and Washington D.C. introduced voluntary uniform policies in 1987, citing improvements in student behavior and a reduced focus on expensive designer clothing. A New York Times report from December 1987 highlighted that most parents supported the new uniform policies, with "almost all" students adhering to the rules. School officials attributed the success of these programs to their ability to reduce discipline problems and alleviate financial burdens on families. The origin of the uniform policy in Baltimore has been linked to a 1986 shooting over a pair of expensive sunglasses, leading schools to implement mandatory uniform policies to promote a safer learning environment.
